Coach for Animals: artificial person offering workshops, courses

Participant: natural or artificial person enrolling for a workshop, course by Coach for Animals

Workshop: workshop, course executed and realised by Coach for Animals

Range of Application

These Terms and Conditions are applicable to agreements on all workshops between Coach for Animals and Participant, even after termination of an agreement, unless parties have explicitly deviated in writing from these terms and conditions.

Registration and entering into an agreement

By registering for a workshop an agreement is made by Participant and Coach for Animals. After enrolment the participant receives confirmation of participation.

Rates

At enrolment for a workshop the rates apply as are mentioned at that time on the website of Coach for Animals. The workshop curriculum lists all matters included in the price.

If VAT is applicable to a workshop the price quoted is inclusive the current VAT rate. Prices will be adjusted if the VAT regime and/or the amount of VAT rates have been altered

Cancellation by Participant

The participant may cancel his enrolment for a workshop without further costs up to 8 weeks before the start thereof.

By cancellation up to 4 weeks before the start of the workshop 50% of the costs will be due.

By cancellation at a later date the whole sum for the workshop will be due. Coach for Animals will endeavour to find a replacement. Coach for

Postponing and cancellation by Coach for Animals

Participant has in that case the right to cancel free of charge. Coach for Animals reserve the right to cancel the workshop latest three day before the start thereof. Participant will be informed straightaway. If Coach for Animals cancel a workshop Participant will be refunded in full for the amount already paid for the workshop.

Invoicing and payment

Immediately after registering Participant will receive an invoice for the costs of the workshop. Our terms are payment in full within 14 days. Should Participant fail to pay or fail to pay in full the costs arising thereof will be for Participant. These costs include all additional and/or court costs.

Changes in the General Terms and Conditions

When changes occur in the General Terms and Conditions the previous Terms and Conditions will still apply to existing agreements.

Waiver

Participating in a workshop is at one's own risk. Coach for Animals accepts no liability for damages, theft, injury of accident incurred by Participant, regardless cause or negligence leading to it.
